The following agreement represents an agreement between For Every Mother, LLC (lessor) and _____, lessee.

1. I do hereby acknowledge and agree that For Every Mother, LLC will lease the water birth tub identified in this rental contract to me, the lessee.
2. I understand that the rental price, \$150 for the Birth Pool in a Box Eco is founded on a per birth basis of a period of approximately 2-4 weeks.
4. I acknowledge that this agreement is non-transferable.
5. I acknowledge that the water birth tub rental is specifically limited to indoor use.
6. I agree to take full responsibility for the manner in and purpose for which said water birth tub is used.
7. I agree to contact For Every Mother, LLC within 3 days of my baby's birth to arrange tub return.
8. I agree to return the water birth tub to For Every Mother, LLC undamaged following its use. I agree to return the water birth tub within 10 days of birth or I will be charged an additional \$25 per week.
9. I agree to pay full retail price for the replacement or repair of said water birth tub in the event it is damaged, not returned to For Every Mother, LLC, or rendered unusable while in my possession.
10. I agree to release and hold harmless For Every Mother, LLC and/or any agent thereof, its members, employees, associates, and affiliated manufacturers from any and all responsibility or liability for maternal complications, infant mortality or morbidity, or injury to any or all persons in connection with the use of said water birth tub that may occur before, during, and/or after labor and/or birth in the water birth tub provided by For Every Mother, LLC.
11. I specifically hold For Every Mother, LLC harmless from any claims made by third parties, as well as any damage or injury to property occasioned by the use of the water birth tub during the rental period or while the water birth tub is otherwise in my possession, and I further more agree to indemnify For Every Mother, LLC for any and all liability or expenses, including attorney's fees, incurred by For Every Mother, LLC occasioned by the use of the water birth tub during the rental period or while the water birth tub is otherwise in my possession.
12. A non-refundable \$50 deposit is required to reserve the tub. The \$50 will be applied to the rental fee. The balance of the rental fee is due upon receipt of the tub.
13. I understand that there will be no reduction in the rental fees if the water birth tub is unused during the rental period or if the tub is returned before the end of the rental period. The reason for this policy is that my reservation of the tub makes it impossible to rent the tub to anyone else during the rental period. Once I have received the tub, it is considered rented, whether I use it or not.
14. I understand that the deposit is nonrefundable, and that no portion of the deposit will be refunded.

I, the undersigned, am 18 years of age or older, have read, understand and agree to the terms outlined above.
